- 1) **Thuja Occidentalis**: Often recommended for common warts, especially those that are large, cauliflower like, and located on the genitals or around the anus (Boericke, 1927).
- 2) **Causticum**: Used for warts that are hard, painful, and located on the hands or face, often accompanied by a burning sensation (Kent, 2008).
- 3) Nitric Acid: Suitable for warts that bleed easily, are painful, and have sharp, splinter like pains (Clarke, 1985).
- 4) Antimonium Crudum: Indicated for warts that are hard and horny, particularly on the soles of the feet or palms (Vermeulen, 2004).
- 5) **Dulcamara**: Effective for warts that appear during damp weather or in individuals who have a tendency to develop warts in moist conditions (Murphy, 1993).

## 2. Case Studies

### Case 1: Thuja Occidentalis for Common Warts

- **Patient Profile**: A 25 year old male presented with multiple large, cauliflower like warts on his fingers. The warts were not painful but were unsightly and bothersome.

#### **Case 3: Nitric Acid for Bleeding Warts**

- Homeopathic Intervention: Nitric Acid 30C was chosen due to the nature of the warts and the associated symptoms.
- **Outcome**: The patient noticed a decrease in bleeding and pain within two weeks. Over a period of six weeks, the warts began to heal, and walking became more comfortable. The treatment was continued for another month to ensure complete resolution.
